## CAC-

- Currently in their accreditation process
- CAPC providing CAC oversight Eva would like to discuss with other interested CAPC members
- Oversight historically was led by CAPC director and was listen in various plans. This needs to be revisited.
  - O Direction needed on talking through some of the quality assurance pieces coming being brought forth from the CAC
- Ginger shares historical oversight board for CAC, explaining changes in leadership and roles
  - O Structure of leadership within CAC is different now; no on-site doctor, no "solo CAPC Director position", more shared interviews etc.
  - o Ginger's role within the County as Senior Management also means directly working with Child Welfare
  - O Discussion: There aren't clearly defined roles across the board because nobody really works or reports to the CAC. With a new round of accreditation, everyone is grappling with the reality that it is hard to make decisions and changes when nobody has any decision making power in that space. There isn't a formal organization with a board in place. Solutions need to get figured out at different types of levels, like what is overall macro CAPC role and level of involvement? And for different agencies, how do we move forward at the front line level to establish procedures that work to continue to have our CAC fully accredited
  - O Board agrees a decision needs to be made on whether CAPC is no longer the oversight entity and gets removed from plan or what the oversight looks like (needs to be defined) 3 collaborative options:
    - > CAPC be the governing committee
    - > Creating a sub-group within CAPC to be the governing committee
    - > Potentially modifying the protocols to develop a working group of the leaders of various agencies to then form a new committee of leaders to manage

To start, Eva would like to meet with the core leadership team. DA, BH, CW, MCRCC and NMC.
